# Wisconsin Lions Camp Diabetes Family Camp Weekend 2022

Come join our Diabetes Family Camp weekend to network with other newly diagnosed families, enjoy a weekend getaway and even learn a few things. The weekend is Friday October 14 through Sunday October 16, 2022. Arrival is on Friday, October 14 between 4 PM - 8 PM (supper meal is provided) with departure on Sunday October 16 by 11:30 AM. The weekend is free of charge - the only two requirements are that your family must have a child who was diagnosed with diabetes in the last year (after October 17, 2021) and that you reside in Wisconsin.

### Lodging:

You will be housed in cabins with 10 beds inside a duplex unit (one cabin on each side) that share a common lounge with each cabin having its own bathroom. The buildings are heated and air conditioned. Bedding is provided (sheets, blankets and pillow) or bring your own to be comfortable.

#### Meals:

All meals will be served buffet style. Meals provided will include supper on Friday, breakfast, lunch and supper on Saturday (including snacks and evening s'mores) and breakfast on Sunday with a "to-go" lunch if desired.

## **Tentative Activity Schedule:**

- Camp activities for all that include boating, swimming (we'll see!), nature, crafts, wagon rides, hiking, ropes course and so much more.
- Networking and discussion with each other to learn more available resources, sharing your diabetes adventure and meeting others in the same situation.

#### A few Camp Policies!

- Because this is free-of-charge to families, we would appreciate a phone call from families if they need to cancel or unable to attend.
- The Lions Camp is not responsible for any loss or damage to personal property of the participants.
- The Lions Camp does not provide any health and accident insurance for the participants. Participants must carry their own insurance or be prepared to pay for cost of any medical services required while at the Camp.
- The Lions Camp does not provide nursing services, diabetes treatment supplies (including insulin), or other medical care in this program. Emergency medical care is available in Stevens Point or via 911.
- Program equipment such as boats, sand toys and nature equipment are all provided by the Camp.
  Those wishing to fish are encouraged to bring their own fishing equipment and bait (no minnows
  please). All Wisconsin fishing rules apply to this lake and we encourage catch-and-release.
- The camp will have a tentative schedule laid out for you of activities we will be leading and what times they will take place. Please note that all children under 18 must be supervised by a parent or guardian on all activities unless specified on the schedule.
- You may drive on Camp for unloading purposes but must park all vehicles in the parking lot.
- Camp is a drug free zone and smoking, vaping or juuling is only allowed at the front gate smoking area.
- ATVs or other motorized vehicles, fireworks, power tools, roller blades, scooters, skateboards or snowboards are not permitted. Personal sports equipment such as tennis racquets can be brought to use, but the Wisconsin Lions Camp is not responsible for any loss or damage of the equipment.

- Camp is a weapons free campus, no firearms, hunting bows or equipment, or ammunition is allowed.
- Service animals are allowed on Camp property, but no other pets are allowed.
- The emergency camp phone number is 715-572-8179. Most cell phones can get service here and there is a limited wireless connections on Camp in the main buildings.
